

# ***Agriculture Development Council Meeting Minutes***

May 18, 2021

## **I. Call to order**

Chair Amy Kellogg called to order the meeting of the Agriculture Development Council at 9:06 am on Tuesday May 18, 2021.

## **II. Roll call**

Dani Jones conducted roll call and introductions were made my council members and department staff.

## **IV. Approval of the past meeting minutes**

John Wicks made the motion to approve the meeting minutes from previous Council meetings, February 17-19, 2021 and April 29,2021 as presented. Director Scott Osterman 2nd the motion. All in favor, motion passed.

## **V. Department Update**

Andy Fjeseth updated the Council on the changes at the Department. Director Foster is headed to the governor's office to oversee the ARPA funds. Andy discussed the Agriculture Resiliency program with "tour stops" that Christy Clark is headed to speak at, starting this afternoon. Alicia Hamm with the Marketing Division introduced herself to the Council.

## **VI. GTA Funding Priorities 2022**

Jim discussed the funding priorities for GTA for the 2022 year, which qualify for 0% interest loans, postponing GTA for ARPA (Ag Resiliency Program). Staff recommendation is to wait to set priorities until we know more about what GTA/ARPA will look like.

1. Commerce Director Scott Osterman initiated the discussion about the impact on growers who are counting on this funding and cycle time.
2. Council agreed that postponing the GTA funding opportunity would be the best approach.
