Eastern Montana Research Center – Chengci Chen - \$60,000 (Tractor)

Director Conover moved, and Director Bumgarner seconded the motion to approve the proposal for \$60,000. The motion passed unanimously.

3 re-negotiated proposals (Wanner, Dyer & Lachowiecz) - \$19,968

Director Bumgarner moved, and Director Carney seconded the motion to approve the proposals for \$19.968. The motion passed unanimously.
