Review of October 27, 2015 Meeting Minutes

Department of Agriculture Update

Director de Yong talked about the trouble with one of the northern ports closing early and upsetting truck traffic. He will be bringing this issue to the governor in the next couple weeks. There are still a few problems with the Canadian trade and they are continuing to talk to the Canadians about the issues.

The Director updated the board on the Pulse crops and the possibilities in India. The department is also working on the new fees for pesticide training for the next legislative session.

Barley Update

Dave Tweet gave a brief update on the barley in the state and how wheat prices are down so are barley. This is barley contracting season and most have finished, some producers are holding out for higher prices.

MSU Report

Kevin Brown gave the report on behalf of Dr. Boyer who was unable to attend the meeting. He told the committee that this is the 8th straight year of growth in the MSU Ag department. They are continuing to raise funds for the endowed chair and are looking at corporate donors.

U.S. Wheat Associates (USWA)

Director Kolstad updated the committee on the meeting he, Chairman Schock and EVP Watters attended in Tahoe. He went to the Long Range Planning committee meeting where foreign markets were discussed. There has been no support for a national checkoff. In the Quality Committee planting is down mostly because of the price of wheat and VP Watters commented on the quality of the winter wheat not doing so well. Chairman Schock thought the speakers were very interesting.

Director Kolstad also attended the Montana Farm Bureau Convention held in Missoula; he noticed an increase of young people at this convention.

Association of Latin American Millers (ALIM)

Chairman Schock attended the ALIM conference in Argentina, he reported that they changed the format back to previous years and it was well attended. South America could be a good opportunity to market U.S. wheat.

Director Mattelin talked to the board about the Durum Forum; the durum crop was a good crop with good quality. They discussed a new durum variety and sustainability.

Director Hinebauch went to Minneapolis to attend the NCI Board Meeting. They toured a pasta plant and a machinery plant, met the new hires at NCI. There was also a discussion on market place trends.
