## Financial Report and Collection Update

## MT Department of Agriculture Update

Deputy Director Mangold let the committee know that the increase of the assessment cap had passed the legislature. The first Hemp Advisory meeting is being held April 3, 2019. The federal government shutdown effected the State Grain lab and caused some delays, they now have two more trained inspectors for wheat. The hail board meeting will be held March 26, 2019.

## **Transportation Update**

Zach Coccoli informed the board that the Rail Service Competition Council has been defunded and will disband.

## MSU Update

Dr. Bajwa introduced herself to the board, then gave an update on the bills going through the legislature including Romney Hall and money for new greenhouses. She would also like to have the ranch system program back at the university.

Mark Jirik introduced himself to the committee and updated them on what is going on at the institute including new classes and some new personnel.

Directors O'Hara and Bumgarner traveled to Colombia to attend this meeting, most of the talk was about the US/Canada/Mexico trade talks. Barley was discussed, and the domestic market has become a focus.

## **National Barley Growers Association**

Director O'Hara and EVP Watters went to Washington DC for this meeting the discussion centered around trade issues and the strategic planning the group is working on.

## **National Barley Improvement Committee**

Director O'Hara attended this meeting in Washington DC, the group meets with representatives and senators to educate them on barley issues. The beer industry is growing here and all over the world, he learned that Ohio has its own malting plant and is planting its own barley because of the demand.

#### **Technical Transfer**

Daniel Juliano explained to the board some of the changes that have taken place in his office, and how they will benefit the breeding programs.

## Wheat Quality Improvement Team
