Evaluations are scored based on project type specific criteria with a maximum score of 100. Scores are averaged by voting members and advisory members, then added together for a total evaluation score. Applications are ranked from hi to low based on total score. Ranking and scores are only part of the Council's funding recommendation decision and serve as a starting point for deliberations; they do not guarentee funding.
