Map Example

Colored maps from Google Maps or FSA are preferred.

- Map size must not exceed 8 ½ X 11 inches
- Maps for large tracts of land can be submitted in a similar manner that meets the requirements
- Show the border, shape and size of the site
- Identify locations of crops and fallow land
- Identify areas of erosion, woodlands, wetlands, wildlife habitat, invasive species
- Indicate areas that separate your site from other land use such as roads, canals, fences and open land
- Identify all adjacent land use
- Identify and label borders at risk for contamination with prohibited materials
- Use the following symbols to indicate specific areas on the site map:
